Submissions must include the following information:

- 1. Your full name, postal address, and if possible a contact telephone number or fax number.
- 2. The name of the person whose submission you support or oppose.
- 3. The particular parts of the **submission** to Proposed Plan Change 2 to the Regional Freshwater Plan for the Wellington Region to which your **further submission** relates.
- 4. Whether you support or oppose the submission.
- 5. The reasons for your support or opposition.
- 6. The decision you seek.
- 7. Whether you wish to be heard in support of your submission.
- 8. Whether, if others are making a similar submission you would, or would not, be prepared to consider presenting a joint case with them at any hearing.

Submissions must be signed and dated.

Clause 8A of the First Schedule of the Act requires that within five working days of making your further submission to the Greater Wellington Regional Council, you must serve a copy of your submission on the party who made the original submission.
