

Conditions - WGN 960002

Standard Conditions for all Permits

- (1) *This consent is subject to all relevant provisions of the Resource Management Act 1991, its amendments and any regulations made thereunder. It is the obligations of the consent holder to comply with all the statutory requirements relating to the exercise thereof.*
- (2) *The consent holder may keep all such records as may be reasonably requires by the Wellington regional Council and shall, if so requested, supply this information to the Wellington Regional Council.*
- (3) *This consent is subject to the Wellington Regional Council or its servants, or its agents, being permitted access at all reasonable times for the purpose of carrying out inspections, measurements and the taking of samples.*
- (4) *The design and maintenance of any works relating to the exercise of the consent must be to a standard adequate to meet the conditions of the consent.*
- (5) *An annual charge, set in accordance with section 36(2) of the Resource Management Act 1991, shall be paid to the Wellington Regional Council for carrying out its functions under section 35 (duty to gather information, monitor and keep records) of the Resource Management Act 1991.*

General Conditions for all Permits:

- (6) *The discharge shall remain the responsibility of the consent holder and shall be operated to the satisfaction of the Manager, Consents Management, Wellington Regional Council.*
- (7) *The permit holder shall keep a record of any complaints received. The complaints shall be forwarded to the Manager, Consents Management, Wellington Regional Council, within twenty-four hours of being received by the consent holder. The permit holder shall record the complainants name, time of incident that caused the complaint, and weather conditions.*
- (8) *The permit holder shall notify the Manager, Consents Management, Wellington Regional Council and the Medical Officer of Health, Public Health Service, within 24 hours of any overflow occurring.*
- (9) *The permit holder shall place and maintain signs on the river/stream banks, to the satisfaction of the Manager, Consents Management, Wellington Regional Council. The signs shall:*
 - (a) *provide clear identification of the location and nature of the discharge and the risk to public health from bathing and collecting food in the vicinity of the discharge.*
 - (b) *be visible to the public visiting the area without unnecessarily detracting from the visual amenity of the area.*

The said signage shall be placed as soon as practicable after the date of commencement of this consent.

- (10) *The permit holder shall take all reasonable steps to investigate and implement ways and means of minimizing infiltration and stormwater ingress into the sewerage system and provide the Manager, Consents Management, Wellington Regional Council with an annual progress report.*
- (11) *The permit holder shall provide the Wellington Tenth Trust with a report on the overflows, and the status of the pumping stations as they are upgraded, on an annual basis.*
- (12) *No overflows shall discharge into the watercourse during dry weather flow.*
- (13) *The permit holder shall monitor the flow rate and duration of any overflows, and shall report the results of this monitoring to the Manager, Consents Management, Wellington Regional Council, at three monthly intervals, or upon request.*

Specific Conditions for Discharge Permit WGN 960002 (01): To intermittently discharge wastewater to Hutt River from the Silverstream River Crossing Overflow

- (14) *The permit holder shall operate the discharge in general accordance with the consent application and associated appendix “Hutt Valley Wastewater Overflows Assessment of Environmental Effects”, February 1998, lodged with the Wellington Regional Council.*
- (15) *This permit shall expire 20 years from the date of commencement of this permit.*
- (16) *The Wellington Regional Council may review any or all the conditions of this permit by giving notice of its intention to do so pursuant to section 128 of the Resource Management Act 1991, within six months of the first, third, fifth, tenth, and fifteenth anniversary of the date of commencement of this permit in order to deal with any adverse effects on the environment which may arise from the exercise of this permit.*

Specific Conditions for Discharge Permit WGN 960002 (02): To intermittently discharge wastewater to Hutt River from the Barber Grove Pump Station.

- (14) *The permit holder shall operate the discharge in general accordance with the consent application and associated appendix “Hutt Valley Wastewater Overflows Assessment of Environmental Effects: February 1998, lodged with the Wellington Regional Council.*
- (15) *This permit shall expire 20 years from the date of commencement of this permit.*
- (16) *The Wellington Regional Council may review any or all the conditions of this permit by giving notice of its intention to do so pursuant to section 128 of the Resource Management Act 1991, within six months of the first, third, fifth, tenth, and fifteenth anniversary of the date of commencement of this permit in order to deal with any adverse effects on the environment which may arise from the exercise of this permit.*

Specific Conditions for Discharge Permit WGN 960002 (03): To intermittently discharge wastewater to Hutt River from Mary Huse Pump Station.

(14) *The permit holder shall operate the discharge in general accordance with the consent application and associated appendix “Hutt Valley Wastewater Overflows Assessment of Environmental Effects: February 1998, lodged with the Wellington Regional Council.*

(15) *This permit shall expire 7 years from the date of commencement of this permit.*

(16) *The Wellington Regional Council may review any or all the conditions of this permit by giving notice of its intention to do so pursuant to section 128 of the Resource Management Act 1991, within six months of the first, third and fifth anniversary of the date of commencement of this permit in order to deal with any adverse effects on the environment which may arise from the exercise of this permit.*

Specific Conditions for Discharge Permit WGN 960002 (04): To intermittently discharge wastewater to Hutt River from Welton Scour.

(14) *The permit holder shall operate the discharge in general accordance with the consent application and associated appendix “Hutt Valley Wastewater Overflows Assessment of Environmental Effects: February 1998, lodged with the Wellington Regional Council.*

(15) *This permit shall expire 7 years from the date of commencement of this permit.*

(16) *The Wellington Regional Council may review any or all the conditions of this permit by giving notice of its intention to do so pursuant to section 128 of the Resource Management Act 1991, within six months of the first, third and fifth anniversary of the date of commencement of this permit in order to deal with any adverse effects on the environment which may arise from the exercise of this permit.*

Specific Conditions for Discharge Permit WGN 960002 (05): To intermittently discharge wastewater to Hulls Creek.

(14) *The permit holder shall operate the discharge in general accordance with the consent application and associated appendix “Hutt Valley Wastewater Overflows Assessment of Environmental Effects: February 1998, lodged with the Wellington Regional Council.*

(15) *This permit shall expire 7 years from the date of commencement of this permit.*

(16) *The Wellington Regional Council may review any or all the conditions of this permit by giving notice of its intention to do so pursuant to section 128 of the Resource Management Act 1991, within six months of the first and third anniversary of the date of commencement of this permit in order to deal with any adverse effects on the environment which may arise from the exercise of this permit.*

Specific Conditions for Discharge Permit WGN 960002 (06): To intermittently discharge wastewater to Awamutu Stream.

(14) *The permit holder shall operate the proposed discharge in general accordance with the consent application and associated Appendix “ Hutt Valley Wastewater Systems Overflows Assessment of Environmental Effects” February 1998, and the amendments as illustrated in Table 7.2 Summary of key mitigation measures and proposed works programme lodged on 8/10/98, and the additional information in the document entitled Leighton Avenue Wastewater Catchment Overflows Investigations Summary, dated 8/10/98.*

- (15) *This permit shall expire 3 years from the date of commencement of this permit.*
- (16) *The permit holder shall respond to any overflow event at Awamutu Stream in accordance with the Management Plan, outlined in the supplementary report to Hutt Valley Waste Water system overflows Assessment of Environmental Effects; Leighton Avenue Wastewater Catchment Overflows Investigations Summary, dated 8/10/98.*
- (17) *The permit holder shall maintain the Awamutu Stream and shall monitor the full length of the stream from bank to bank twice a year, to the satisfaction of the Manager, Consents Management, Wellington Regional Council. The maintenance of the stream shall include but is not limited to, clearing the stream of obstacles, and maintaining a clear flow path.*
- (18) *The permit holder shall identify and provide, to the satisfaction of the Manager, Consents Management, Wellington Regional Council, appropriate locations to sample Awamutu Stream, both upstream and downstream of the discharge point.*
- (19) *The permit holder shall take a grab sample at the sample points identified in condition 18 in Awamutu Stream on each day that an overflow occurs. The sample shall be analysed for biochemical oxygen demand, faecal coliforms, and enterococci concentrations.*
- (20) *Results of monitoring undertaken for condition 19 shall be reported at 3 monthly intervals to the Manager, Consents Management, Wellington Regional Council, or upon request.*
- (21) *From the date of commencement of this permit, the permit holder shall supply the Manager, Consents Management, Wellington Regional Council, with a photographic record of the state of the Awamutu Stream up to completion of the maintenance works, covering the full length of the Awamutu Stream between the Awamutu Grove overflow and Elizabeth Street. The permit holder shall supply these records at six monthly intervals.*
- (22) *The permit holder shall undertake a flood study investigation into the stream channel improvements for the Awamutu Stream, and notify submitters of the results of this study within 9 months from the date of the commencement of this permit. The Stormwater Asset Manager shall submit channel improvement work for consideration by the Hutt City Council as part of the 200/2001 Annual Plan process.*
- (23) *The Wellington Regional Council may review any or all the conditions of this permit by giving notice of its intention to do so pursuant to section 128 of the Resource Management Act 1991, within six months of the first and second anniversary of the date of commencement of this permit for any of the following reasons:*
 - (a) *To deal with any adverse effects of the receiving environment which may arise from the exercise of this permit and which it is appropriate to deal with at a later stage.*

- (b) *To review the adequacy of the monitoring requirement, so as to incorporate into this permit any modifications to the monitoring that may be necessary to deal with any adverse effects on the environment arising from the exercise of this permit.*

Specific Conditions for Discharge Permit WGN 960002 (07): To intermittently discharge wastewater to Waiwhetu Stream from Hinemoa Street.

- (14) *The permit holder shall operate the proposed discharge in general accordance with the consent application and associated Appendix “Hutt Valley Wastewater Systems Overflows Assessment of Environmental Effects” February 1998, and the amendments as illustrated in Table 7.2 Summary of key mitigation measures and proposed works programme lodged on 8/10/98, and the additional information in the document entitled Leighton Avenue Wastewater Catchment Overflows Investigations Summary, dated 8/10/98.*
- (15) *This permit shall expire 5 years from the date of commencement of this permit.*
- (16) *The permit holder shall identify and provide, to the satisfaction of the Manager, Consents Management, Wellington Regional Council, appropriate locations to sample Waiwhetu Stream, both upstream and downstream of the discharge point.*
- (17) *The permit holder shall take a grab sample at the sample points identified in condition 16 in Waiwhetu Stream on each day that an overflow occurs. The sample shall be analysed for biochemical oxygen demand, faecal coliforms, and enterococci concentrations. This monitoring shall be undertaken for the first year and thereafter at intervals to the satisfaction of the Manager, Consents Management, Wellington Regional Council, to determine whether any adverse effects are occurring.*
- (18) *Results of monitoring undertaken for condition 17 shall be reported at 3 monthly intervals to the Manager, Consents Management, Wellington Regional Council, or upon request.*
- (19) *The Wellington Regional Council may review any or all the conditions of this permit by giving notice of its intention to do so pursuant to section 128 of the Resource Management Act 1991, within six months of the first, third and fifth anniversary of the date of commencement of this permit in order to deal with any adverse effects of the receiving environment which may arise from the exercise of this permit and which it is appropriate to deal with at a later stage.*

Specific Conditions for Discharge Permit WGN 960002 (08): To intermittently discharge wastewater to Waiwhetu Stream from Malone Street Pumping Station.

- (14) *The permit holder shall operate the proposed discharge in general accordance with the consent application and associated Appendix “Hutt Valley Wastewater Systems Overflows Assessment of Environmental Effects” February 1998, and the amendments as illustrated in Table 7.2 Summary of key mitigation measures and proposed works programme lodged on 8/10/98, and the additional information in the document entitled Leighton Avenue Wastewater Catchment Overflows Investigations Summary, dated 8/10/98.*
- (15) *This permit shall expire 5 years from the date of commencement of this permit.*

- (16) *The permit holder shall identify and provide, to the satisfaction of the Manager, Consents Management, Wellington Regional Council, appropriate locations to sample Waiwhetu Stream, both upstream and downstream of the discharge point.*
- (17) *The permit holder shall take a grab sample at the sample points identified in condition 16 in Waiwhetu Stream on each day that an overflow occurs. The sample shall be analysed for biochemical oxygen demand, faecal coliforms, and enterococci concentrations. This monitoring shall be undertaken for the first year, and thereafter at intervals to the satisfaction of the Manager, Consents Management, Wellington Regional Council to determine whether any adverse effects are occurring.*
- (18) *Results of monitoring undertaken for condition 17 shall be reported at 3 monthly intervals to the Manager, Consents Management, Wellington Regional Council or upon request.*
- (19) *The Wellington Regional Council may review any or all the conditions of this permit by giving notice of its intention to do so pursuant to section 128 of the Resource Management Act 1991, within six months of the first, third and fifth anniversary of the date of commencement of this permit in order to deal with any adverse effects of the receiving environment which may arise from the exercise of this permit and which it is appropriate to deal with at a later stage.*
