1. **Notified Consents**

See attached sheet.

2. Appeals

Taranaki Wharf

The decision on the Taranaki Wharf development was appealed by Waterfront Watch. While the Wellington Regional Council was named as a respondent to the appeal, it is clear that it does not apply to our consents. Our solicitors have written to the Environment Court explaining the position.

Owhiro Bay Boat Ramp

The Owhiro Bay boat ramp appeal goes to the Environment Court in December 1999.

Paraparaumu and Waikanae Sewage Treatment Plants

We remain in discussions over the Paraparaumu and Waikanae Sewage Treatment Plant appeals. We have reached agreement with KCDC on their appeals on the Paraparaumu consents and we are still working on the Waikanae consents. The other appellant is the Waikanae Residents and Ratepayers Association. We are meeting with them again on 18 October 1999.

Porirua Sewage Treatment Plant

We are in general agreement with PCC over their appeal. Once that is finalised we will seek formal mediation with the other appellant, the Titahi Bay Residents and Ratepayers Progressive Association Inc.

3. **Compliance**

3.1 General

The issues surrounding the C&D Landfill, the Medical Waste Limited incinerator, unauthorised stream works in the Moonshine stream, and the unauthorised use of boatsheds have kept us very busy in the compliance and enforcement area.

Medical Waste Limited

We remain on target to begin the review of Medical Waste's Resource Consent conditions in November. Given the relationship between CentrePort and Medical Waste Limited, it is likely that independent commissioners will hear the review.

Unauthorised Works - Moonshine Stream

We are presently working with the Flood Protection Group, investigating ways we can remediate a series of problems caused by unauthorised works on the Moonshine Stream. A consent holder significantly exceeding the bounds of their resource consent which has meant that there are potential erosion issues both up and downstream. Once we have worked out how best to solve the problem we will decide what further enforcement action needs to be taken.

3.2 **Abatement Notices**

Burrell Demolition, Alex Burrell

We have issued a further five abatement notices to Burrell Demolition Limited and one of its Directors, Mr Alex Burrell, since the last meeting. They relate to a number of problems associated with the C&D Demolition Landfill (See prosecutions below).

Boatsheds

We have issued abatement notices to people who stayed overnight in their boatsheds without a resource consent. They were:

- CE Best;
- Craig Talbot;
- Leslie Merson;
- Ashley Firth;
- Dion Leen; and
- Spencer Giddens,

A further five abatement notices were issued to:

- Powell and Rae Lewis:
- Graham Inwood;
- Darryl Walker; and
- Oriel Martin and Kerrie Mercer.

These people all have resource consents to stay overnight in their boatsheds for up to 35 nights. A requirement is that they log each stay. Our surveillance programme showed that the logs were not accurate.

3.3 **Enforcement Orders**

Anglian Water International (NZ) Limited and Wellington City Council (Moa Point Sewage Treatment Plant)

The application remains adjourned. The independent report on the odour issue is almost finalised and we will shortly meet with all parties to see if we can agree on future actions.

The situation remains much improved on what we had this time last year.

Burrell Demolition Limited, Alex Burrell, C&D Landfill Limited, and John Morgan

On 16 September 1999, both the Wellington City Council and Wellington Regional Council applied to the Environment Court for an Interim Enforcement Order to require the cessation of dumping of material immediately above a culvert intake in the landfill. The Court granted the Interim Enforcement Order.

3.4 **Prosecutions**

Burrell Demolition Limited, Alex Burrell, C&D Landfill Limited and John Morgan.

The defendants have elected trial by jury. We are yet to confirm court dates.

4. Other

Regional Councils' Performance Indicator Project

Councillor's don't hear much about the "behind the scenes" work with other regional councils. However, I'd like to highlight the joint regional council consents performance indicator project, as it should deliver significant benefits to all regional councils. The project should mean that regional councils have the ability to benchmark their consent processing performance and thus drive improvements. This sort of project can only come about because regional councils are prepared to cooperate with each other, even if it potentially means changing our practices.
