1. Consent Statistics

The median processing time for non notified consents is 11 working days. There have been no late consents so far this financial year.

2. Appeals

The decision on the variation of the Living Earth Joint Venture Company's consent conditions has been appealed by the Southern Environmental Association.

The hearing for the Owhiro Bay Boat ramp appeal is set down for 27 March 2000. These consents were granted in September 1998 and spent a year in mediation.

We are making progress over the Paraparaumu and Waikanae appeals. The Paraparaumu appeals are almost completely resolved. We are waiting for KCDC to confirm that they agree to the wording of one condition. Waikanae is a little further behind but the signs are promising for a negotiated solution.

Mediation on the outstanding appeal against the PCC Sewage decision began on 16 November 1999. We have resolved all our outstanding issues with PCC and the mediation is dealing with the concerns of the other appellant (the Titahi Bay Ratepayers and Progressive Association Inc) and interested parties.

3. **Compliance**

3.1 **Medical Waste Limited**

The review of Medical Waste Limited's resource consent conditions was notified on 20 November 1999. Submissions close on 17 December 1999.

3.2 **Abatement Notices**

We have issued an abatement notice against the Wellington City Council that sets out a timetable for the repair of a culvert underneath Cary's Gully landfill. The poor state of the culvert means that leachate from the landfill is presently entering Cary's Gully stream.

3.3 **Enforcement Orders**

Anglian Water International (NZ) Limited and Wellington City Council (Moa Point Sewage Treatment Plant)

The application remains adjourned. You have a separate report on one of our initiatives to resolve the issue.

The situation remains much improved on what we had this time last year.

3.4 **Prosecution**

At this stage we do not have a date for depositions in the C&D Landfill prosecution. However, it is not likely to occur this year.

4. Other

4.1 **ISO Certification**

We are presently going through the preliminary processes of obtaining ISO 9002 certification for our Wellington consent processing and compliance monitoring functions. The process has so far been far less onerous than I expected, possibly because we are simply extending the scope of the registration. The Resource Information section of the Resource Investigations Department is already ISO accredited and we are hoping to add to that.

4.2 **Staffing**

Two students have recently joined us to assist over the summer. Caroline Ryder will be assisting the Resource Advisors during the "compliance season" and Annette McGovern will be doing some work to bring the Compliance module of the CoCo Database up to speed.

4.3 **Infringement Notices**

As of 1 February 2000, we will be authorised to issue Infringement Notices (instant fines) for minor breaches of the Act. I don't anticipate we will issue a great number for breaches of resource consents, but they do provide a very effective enforcement tool.
