# **May 2000**

#### 1. Consent Statistics

The Department's median processing time for non notified consents is 10 working days (187 consents). There have been no late consents so far this financial year (but see remission of charges below).

# 2. Appeals

Since your last meeting we have received one new appeal but three longstanding appeals have been resolved.

The Castro1 discharge to air decision has been appealed by a two submitters.

Medical Waste Limited appealed the commissioners' decision on the review of conditions. We are presently discussing matters with them with a view to a negotiated resolution.

The Owhiro Bay Boat ramp appeals were struck out by the Environment Court. Our application for costs has yet to be determined.

The Paraparaumu and Waikanae sewage appeals have now been resolved and approved by the Environment Court.

We are still working towards a hearing at the end of May for the appeals against the PCC Sewage decision.

We have been offered mediation on the Promall appeals which may resolve at least some of the issues relating to those consents.

# 3. Compliance

### 3.1 **Abatement Notices**

Since the last Committee meeting we have cancelled one abatement notice and reissued it. The abatement notice required the WCC to complete the leachate diversion tunnel by 30 April 2000. In mid April the WCC advised us that the tunnel floor was cracking (apparently the cement used in the job was not up to specification) and that further work in the tunnel prior to it being strengthened would constitute a serious Health and Safety hazard. The new abatement notice requires the works to be completed by 1 September 2000.

#### 3.2 Enforcement Orders

Anglian Water International (NZ) Limited and Wellington City Council (Moa Point Sewage Treatment Plant).

We have instructed our solicitors to uplift the Enforcement Order applications. AWI are proposing to put a venturi device on the top of the stack that they hope will remove the last of the residual odour from the Golf Course. The device will be put in place once they have WCC approval.

#### 3.3 Prosecution and Interim Enforcement Orders

The Burrell Demolition prosecutions are still working their way through the system. We are presently trying to confirm a Court date for declarations on how much timber the landfill is allowed to receive. After that is resolved we will then be able to proceed to depositions.

#### 4. Other

#### 4.1 **ISO Registration**

We have completed our application for ISO registration of our consent processing and compliance monitoring functions. We are to be audited by Telarc in late May.

#### 4.2 Remission of Charges

I remitted a \$180 charge to KCDC for a variation to an existing resource consent. Our response to their request was unsatisfactorily slow so they received a refund.

## 4.3 Customer Satisfaction Survey

The biannual Customer Satisfaction Survey is underway and due to be completed by the end of May.

#### 4.4 Staffing

Annette McGovern and Sarah Wilks have joined the Department as Resource Advisors. Some of you may already know Annette as she has been with us since late last year as a student. Both of them have been thrown in at the deep end with Sarah heading our "miscellaneous discharges" compliance team and Annette in charge of water takes and water treatment plants.
