# Managers Report, Resource Policy Wayne Hastie, Manager

## May 2000

## 1. **Regional Plans**

A summary of the status of the various Environment Court references on regional plans is attached (Attachment 1). Changes from the last meeting are shown in bold.

#### (1) Regional Coastal Plan (Wayne Hastie)

We understand that the Plan has been assessed by Department of Conservation staff and has been passed to the Minister for her consideration. We are hopeful of an early response.

The Minister has agreed in principle to launch the Plan.

#### (2) **Regional Plan for Discharges to Land (Kirsten Forsyth)**

The Plan became operative on 17 December 1999. There is nothing further to report to the Committee since the previous meeting.

#### (3) Regional Air Quality Management Plan (Nicki Kinghorn)

The Plan was adopted by the Council on 13 April 2000 and will become operative on 8 May 2000. It is currently being printed.

#### (4) Regional Freshwater Plan (Kirsten Forsyth, Murray McLea)

The Plan became operative on 17 December 1999. There is nothing further to report to the Committee since the previous meeting.

#### (5) Regional Soil Plan (Nicki Kinghorn)

We are still waiting for the Environment Court to process the final two consent orders. We are also still waiting for Mr Riddiford to withdraw his appeal to the High Court. Both matters are being pursued, and we remain hopeful of an early resolution to both.

### 2. **Regional Plan Implementation**

#### (1) Community and School Beach and Stream Management (Jo Fagan)

As reported to the last meeting, Seaweek cleanups occurred during 11-19<sup>th</sup> March, and the Council supported these through media releases. The cleanups

are organised by Don Richards and his summary and reports on this year's events are attached (Attachment 2).

We have agreed to support Clean Up New Zealand in their campaign which will occur during the period 18 - 24 September 2000.

The Waitohu Coastcare group have been replanting the dune system and cleaning up the foreshore.

#### (2) **On-site Sewage Treatment (Kirsten Forsyth)**

The territorial authorities in the western Region have agreed to the wording of the brochures and a meeting is scheduled with the Wairarapa councils. Design and printing options have been explored and it is hoped that the brochures can be printed in the near future.

#### (3) Review of Air Discharge Problems (Nicki Kinghorn)

We are reviewing the information we have about air discharges in the Region to identify the main contributors of pollutants and the areas that we should focus on when promoting non-regulatory methods to mitigate the effects of air discharges. A summary of the findings and draft recommendations have been sent to Regional Council staff for comment.

#### (4) **Promotion of Code of Practice for the Management of Agrichemicals** (Nicki Kinghorn)

Information has been collected and assessed, and recommendations are being developed. Internal discussions are on-going.

#### (5) Sustainable Land Management (Nicki Kinghorn)

A draft sustainable land management action plan has been prepared, and comment sought from other staff from within the Department prior to the commencement of wider consultation.

### 3. **Iwi matters (Tracey Whare)**

One part of the adopted proposal for strengthening the relationship between the Council and Iwi was to hold technical workshops. Three workshops were programmed this year, and Ara Tahi selected the topic areas. The first workshop on Maori Hearing Commissioners was held on 3 May, and provided a useful opportunity to explore the topic. A follow up workshop is scheduled for 7 June so that Ara Tahi can consider the outcomes on 14 June.

Iwi are being consulted about the internal review of the Regional Policy Statement and about projects that may be suitable for funding by the Council. Details will be reported to the Committee at a later stage.

Proposed changes to the Charter of Understanding were considered by Ara Tahi and were generally well received. We are drafting further changes in response to feedback, and will present the updated revision to the next meeting of Ara Tahi on 14 June.

## 4. Hazards (Jan Hania)

Opus International Consultants Limited have completed a draft report on the relative risk that natural hazards pose to the storage of petroleum products in the Wellington Region. The findings will be reported to the next Committee meeting.

## 4. Staff

Paula Reeves has commenced work as a Policy Advisor. Paula's key areas of work are coastal marine, wetlands, and community involvement. Apart from the position of Cartographer, which is currently frozen pending review, the Department is fully staffed.
