LC125 **Apologies**

Resolved

LC126 Public Participation**John Bailey – Otaki resident**

Mr Bailey said that the opening of an unsealed road from Kapiti Lane to a shingle plant near State Highway 1 has encouraged diverse recreational activities, including the use of motor vehicles up to the river mouth. Mr Bailey requested that barriers be put in down the road sides to restrict vehicle access to the area. He also said that game shooting had scared off local birdlife; that the hunters were noisy and presented a risk to recreational walkers; that vehicle use, especially trail bikes, had caused ecological damage and should be banned; that there was a need to enforce dog control measures; and he requested the area be made a bird sanctuary. He said hunting was incompatible at the river mouth and lagoon.

Lenore Winterburn – Otaki resident, member of Kapiti Wildfowl Group and Friends of the Otaki River

Ms Winterburn said there was a need for culling to stimulate the local wildfowl population. She favoured the status quo and supported varied recreational uses for the area, believing they were not incompatible. The area is tidal and a reserve would be expensive to create and maintain. Ms Winterburn was comfortable with the possibility of restricting motor vehicle access, provided that any such restrictions applied to all members of the public and not just hunters. She said hunting was a winter activity with limited impact on other recreation users.

Ian Murray – Member of Kapiti Wildfowl Group and representing by proxy the New Zealand Fish and Game Council

Mr Murray spoke in support of the Wellington Fish and Game Council proposal for gamebird hunter access to the Otaki riverbed, describing it as reasonable and fair. He said he used the area for environmental education and field-craft training. He also said a wildfowl reserve was not practical because of regular flooding which prevents birds from nesting in the area. A hunting ban would not be practical either because people would still be able to hunt on private land. Mr Murray also said that the vehicle access issue was wider than the area concerned.
