US 92 Public Participation**Paul Hughes**

Paul Hughes said he had been involved in Forestry Management Policy development for over 20 years and was concerned the Regional Council was appearing to ignore the requirements of the Management Plan in its forestry policy in the Pakuratahi Catchment. Mr Hughes also regretted the Council had apparently not yet published the net income from logging in the catchment.

Councillor McQueen thanked Mr Hughes for his representations and said the broader issues raised would be debated by the Regional Council at its Policy and Finance Committee.

Albert Landon, Petone

Mr Landon said he had enjoyed many years of drinking non-fluoridated water from the Petone water supply and could see no reasons for closing down the Buick Street Pumping Station. Mr Landon asked the Regional Council to reconsider its decision to close the Station and said he was sure that it could be re-opened at small cost.

Mary Burn, Petone

Mary Burn said misleading information had been circulated about fluoridated water and questioned the health and dental statistics to support its inclusion in Petone water. The Regional Council should hold a region wide referendum, before more dollars were spent on a new Pumping Station.
