- (1) *That the tender submitted by Works Infrastructure for Contract No. 1191 for the sum of \$197,400.00, excluding GST, be accepted, noting that the total of scheduled items in the Contract is \$191,860.00.*
- (2) *That expenditure of an additional 10 percent of the accepted Contract Sum be approved to allow for unforeseen circumstances.*
- (3) *That the Common Seal of the Wellington Regional Council be affixed to the necessary documents of Contract No. 1191.*
- (4) *That prior to awarding Contract No. 1191 the Wellington Regional Council enter into an agreement with the Rallywoods Partnership for reciprocal access between Valley View Forest and Bulls Run Road.*
- (5) *That the Wellington Regional Council will within this agreement increase the contribution to approximately \$185,000 towards the cost of the Rallywood Bridge construction.*
- (6) *That the Wellington Regional Council will bear the total Contract Sum and recover \$40,000 from the Rallywoods Partnership.*
- (7) *That additional expenditure of up to \$65,000 be added to the budgeted expenditure of \$170,000 for the 1999/00 financial year, as reported in Report No. PE-99.582, bringing the total of the revised budgeted expenditure for the 1999/00 year to \$235,000.*
- (8) *That, alternatively, if a satisfactory tender for a lower Contract Sum utilising precast concrete components is received, the tender will be accepted by the Divisional Manager, Utility Services under delegated authority.*
