- (4) accepts, in conjunction with the Wellington City Council, the resignation as a Trustee of Bryan Johnson and note the valuable contribution made by Bryan to the Stadium Project.
- (5) reappoints, in conjunction with the Wellington City Council,
  - (a) John Hunn as a Trustee for a term of a further two years.
  - (b) Ngatata Love as a Trustee for a term of one further year (subject to Ngatata Love offering himself for reappointment).
- (6) in the event that Ngatata Love does not offer himself for reappointment as a Trustee appoint, in conjunction with the Wellington City Council, a new Trustee for a term of one year (with the new Trustee appointment being subject to prior Council approval).

(7) That Councillor Buchanan, Wellington Regional Council and Councillor Armstrong, Wellington City Council, be given an extension of term as Trustees on the Stadium Trust until 20/12/01, subject to agreement with the Wellington City Council.
