Report to Ara Tahi from Keriana Wilcox, Māori Policy Advisor (Wellington) and Jason Kerehi, Māori Policy Advisor (Wairarapa)

Progress Report from Māori Policy Advisors, Wellington and Wairarapa

1. **Purpose**

To provide Ara Tahi with an update for the months of October and November, 2002.

2. Training Initiatives

2.1 Wetland Technical Workshop

The next Councillor training will be held on 4 December 2002. This will be hosted by Te Ati Awa ki Whakarongotai at Waikanae. Details to follow.

3. Administration Putea Funding

Report 02.613 presented at the last Ara Tahi meeting outlined feedback received from Iwi and Greater Wellington – The Regional Council on the administrative capacity funding for the 2001/2002 financial year. It was agreed that the current funding arrangement was satisfactory and that it should continue for the 2002/2003 financial year.

Draft contracts and a copy of the reporting template has been sent to all Iwi for comment. We have heard back from 5 Iwi Groups thus far and will be sending final contracts to these groups for signing as soon as possible. We can then organise payment of monies.

Iwi groups will be providing their first written report to Greater Wellington by 15 February 2003.

5. Treaty of Waitangi Framework

Ara Tahi members participated in a review of the Charter of Understanding in 2000. These discussions prompted changes to the Charter and suggested that Greater Wellington look at undertaking a number of specific policy projects. One of the suggestions was the development of a Treaty of Waitangi analysis framework. This would ensure that all staff reports include a Treaty of Waitangi section, requiring report writers to consider Treaty implications.

Recently, the Parliamentary Commissioner for the Environment produced a document "He Rangahau ki te aria ko te Tiriti te putake e whakatuturutia ai nga tikanga mo te taiao", which examined Treaty based audit frameworks being used around the country. It stated that Treaty implications are an issue that should be considered by Local Government in light of the Local Government Bill. It also stated that organisations need to look at how responsive they are to the needs and aspirations of Māori overall.

A report by the Centre for Research Evaluation and Social Assessment (CRESA) on "Local Government Relationships with Maori", has briefly outlined mechanisms, processes and practices that Greater Wellington uses to meet its Treaty obligations (Attachment 1: Executive Summary). While this report has not provided a critical analysis of Greater Wellington's responsiveness to Māori, it has provided a snapshot of what we are presently doing to pursue meaningful and beneficial relationships with Māori.

Discussions at Ara Tahi meetings and possible amendments to the Local Government Act suggest it is timely for Greater Wellington to undertake a Treaty Responsiveness exercise. This process would identify expectations, what we are doing well, what we do not do well and what areas we need to look at improving or change in terms of meeting the obligations of the Treaty.

As you can imagine, this will not be an easy task. The first part of this project is therefore to prepare a pre-plan of the intended exercise, so we can get an idea of its scope.

We would like the input and assistance of Ara Tahi members and Greater Wellington Councillors at a number of stages of the projects development. The project will therefore be the subject of a series of workshops early next year. You will also be kept up to date with all developments as they occur.

6. Ngati Tama Relationships with Greater Wellington

On 23 September 2002, Greater Wellington received a letter from Selwyn Katene on behalf of Ngati Tama ki te Upoko o te Ika. The letter stated that Ngati Tama would like to re-establish itself as an Iwi organisation in Wellington, and establish a Treaty Partnership relationship with Greater Wellington, including membership of its governance committee.

The Charter of Understanding states that:

"All parties remain open to the possibility of new parties joining Ara Tahi. If a new party communicates to the Council their desire to join Ara Tahi, their request will be brought to Ara Tahi. Ara Tahi will then decide on a process to determine whether such a group will be invited to be part of Ara Tahi and a signatory of this Charter".

Therefore, we are obliged at some stage to address this issue through the Ara Tahi forum.

In recognition of the Manawhenua status of Te Ati Awa in the Wellington City area we held discussions with Wellington Tenths Trust and Te Runanganui o Taranaki Whanui to discuss this matter. On their advice we will be waiting for the release of the upcoming WAI 145 report from the Waitangi Tribunal. It is hoped that mandating issues will become clearer after the release of this report.
