# **Progress Report - Mäori Policy Advisors**

## 1. Purpose

To provide Ara Tahi with an update for the months of April and May.

# 2. Staff Training

Jason gave a presentation about Maori history to Wairarapa staff in early May. He plans to give a similar presentation to Upper Hutt staff.

A 10-week introductory Te Reo course commenced on 21 April 2004. There are 16 people enrolled on the course, including five from the Wellington City Council.

Jason and Rawiri speak to new staff members at induction sessions about Greater Wellington's responsibilities under the Resource Management and Local Government Acts.

## 3. Iwi projects

#### 3.1 Capacity funding report template.

Rawiri and Jason have met with all iwi authorities to discuss the format and wording of the reporting template. As agreed by Ara Tahi, the first half of the 2004/2005 capacity funding will be paid upon receipt of an adequate report in July.

Iwi projects for the next financial year were also discussed. Iwi will be notified directly once the project proposals have been reviewed.

The Local Government New Zealand conference is in Auckland from 25-28 July 2004. Last year Liz Mellish attended the conference in Queenstown. As discussed at the Ara Tahi hui on 24 March, Greater Wellington will fund a member of Ara Tahi to attend this years conference.
