**Mr Handley Thomson – Chairman, AA Wairarapa District**

Mr Thomson spoke of the need for stock truck effluent sites in the Wairarapa and commented on the current situation whereby an

environmental issue existed with stock effluent being unsightly, smelly, and in turn damaging road surfaces. No sites in the Wairarapa had been planned in Transit's list of effluent disposal sites for construction over the next 3 years, and he believed that provision needed to be made for a disposal site in the vicinity of the saleyards at the south end of Masterton and a further site in south Wairarapa before the Rimutaka Hill.

He considered that a good outcome would be for discussions to commence with Transit to investigate the need for effluent disposal facilities throughout the Wellington region and to also initiate an educational awareness campaign.

**Concerning 3.2 Barrage Gates**

The Committee was made aware of the current low levels in Lake Wairarapa resulting from the required painting of the Barrage Gates which could impact on the forthcoming duck shooting season.

The Committee's attention was also brought to the need for an educational programme to be run in conjunction with the SPCA regarding feral cats.

Mr Dalziell stressed the importance of landowners dealing with the control of gorse on their properties where he believed the spread of gorse had become worse over the last 5 years and would effectively become a long term issue and even bigger boundary issue problem in the future if not dealt with now. Ragwort was seen as another pest plant requiring an awareness programme to be initiated.

### **Concerning 4.15 Juken Nissho Ltd and SE Wairarapa**

The Committee was informed that major issues were involved with Juken Nissho still maintaining their policy to not allow access for Greater Wellington to use 1080 control methods.

Mr O'Donnell also indicated that Stage 3 of the South East Wairarapa aerial operation was unlikely to proceed this financial year because of issues around the use of deer repellent.

Mr Dalziell indicated that the Animal Health Board were lobbying both issues in Wellington. He gave a brief summary indicating that there was an area for negotiation in relation to the JNL issue and an attempt was being made to ensure there would be no delays with the SE Wairarapa operation.
