He noted that David was an internal applicant who had been at Greater Wellington since 1989, during which time he had held the positions of Chief Financial Officer and Divisional Manager Utility Services.

5. Maori constituency

Graham Cameron went through this paper and asked Ara Tahi for their opinion on whether or not the Council should establish Mäori constituencies.

7. RLTS Review – Strategic Options

Joe Hewitt discussed the strategic options consultation document that forms part of the Regional Land Transport Strategy (RLTS) review and encouraged Ara Tahi and individual iwi to make submissions on the options document. Joe also mentioned that there was a draft travel demand management strategy which was being sent to iwi.

Jack Rikihana briefly discussed last week's Regional Land Transport Committee meeting and Terry McDavitt explained the different steps required before the RLTS could be finalised (see below).

Western Corridor submission process – decision on which is the best option – RLTS priorisation process – Transit approval process – resource consent process

8. Findings from the Heritage and Landscape Work for the State of the Environment Report

John Holmes presented this report. He said that the recent consultation on the document was limited to the territorial authorities and landscape industry workers, but that iwi would be consulted on the Regional Policy Statement which the State of the Environment Report feeds into.

Tom Paku mentioned that many iwi organisations would be open to being approached about helping to establish a regional incentive fund. John Holmes said he would pass this message on to the Historic Places Trust.

Graham Cameron presented this report. He checked that everyone could attend the Hui-a-Ara Tahi on 30 October and 1 November 2005. He also said that the funding contract payments only related to the months July – December because they were waiting for the outcome of the iwi relationship review. Graham noted that Ngati Toa Rangitira had almost completed their iwi project.
