- (1) Receives the report.*

- (3) Continues to undertake Bovine TB vector control work by retaining BioWorks as outlined in Option 1, subject to the Chief Executive:*
  - successfully negotiating a 2 year 60,000 hectare preferred supplier contract with the Animal Health Board at an acceptable price.*
  - being satisfied that BioWorks has a reasonable expectation of winning the remaining required work on open tender to meet its financial targets.*
  - being satisfied that the retention of the unit will not impair Council's chances of renewing its vector management contract with the Animal Health Board from 1 July 2008.*
- (4) Requests the Chief Executive to prepare a new business plan for the BioWorks unit which sets out the operating mandate for the unit, budget and profitability targets, key performance indicators and monitoring procedures. Such plan to be presented to the 4 September Committee meeting.*
- (5) Agrees that, should the Council's vector management contract not be renewed beyond 1 July 2008, that Council would need to carefully reconsider continuing vector control.*
- (6) Notes that Options 2 and 3 remain open to the Council should the performance of the unit not meet targets, or market or industry conditions change.*
