## 4. Passenger Transport Committee: role and current activities

#### **Oral Presentation**

Cr Glensor spoke on the role and current activities of the Passenger Transport Committee, as well as outlining future activities. Ara Tahi raised concerns surrounding the provision of school buses. Members noted that the Council is not responsible for these services, (the Ministry of Education and the individual schools are) but enquired as to the extent that the Council is involved with those services run by Stagecoach and Metlink, as well the level of accountability and influence the Passenger Transport Committee has over such services.

Ara Tahi members also raised the issue of bus safety in the inner city. Cr Glensor explained that it was not as bad as has been reported – out of the 100 pedestrian/vehicle incidents, seven of those were buses.

# 5. Wellington Regional Settlement Strategy

Report 07.329 File: X/16/07/01

Officials from the Department of Labour informed Ara Tahi of the Wellington Regional Settlement Strategy and outlined the proposed steps it would be taking in regard to consultation with Iwi in the Wellington Region. Ara Tahi expressed reservations at joining the strategy, and decided to caucus at some time on the matter to bring issues to the table before making any decisions regarding their level of involvement in the strategy.

Ara Tahi members enquired into the balance between up-skilling and educating the local labour market against and the settling of new immigrants. Members emphasised the importance of putting skills in place that would remain, rather than calling in labour from overseas when it is needed.

Although Ara Tahi decided to convene at another time to discuss the strategy, they stressed the importance of ensuring that issues of cultural awareness are addressed, specifically that new immigrants are settled with an understanding of the culture they are entering into.
