Amendment of Proposed Natural Resources Plan pursuant to clause 16 of Schedule 1 to the Resource Management Act 1991

Clause 16 of Schedule 1 to the Resource Management Act 1991 provides for the Wellington Regional Council to make amendments to the Proposed Natural Resources Plan, without using the process set out in Schedule 1, to alter any information, where such an alteration is of minor effect, or to correct any minor errors.

The Manager, Environmental Policy, Wellington Regional Council, has considered the relevant provisions in Appendix 1 against those tests (alteration of minor effect or corrections of a minor error) and acting under authority delegated by the Wellington Regional Council, has decided the amendments to the Proposed Natural Resources Plan as set out in Appendix 1 meet those tests and are made accordingly.

There were previous amendments made under clause 16 of Schedule 1 to the Resource Management Act 1991 to the Proposed Natural Resources Plan (see memos dated 19 November 2019 and 24 August 2022). The amendments now approved are in addition to those amendments, Appendix 1 contains the current list of amendments being made.
