Request for information 2023-115

I refer to your request for information dated 8 May 2023, which was received by Greater Wellington Regional Council (Greater Wellington) on 8 May 2023. You have requested the following:

"I'd like to see the full financial plan - p&l, cashflow and balance sheet."

On 11 May 2023 you had a follow up clarification requesting the following:

"Please send me the 23/24 financial budgets and your long term financial forecasts asap"

Greater Wellington's response follows:

The 2021-31 Long Term Plan (LTP) information you have requested is publicly available information and can be found on the following web page, <u>https://ltp.gw.govt.nz</u> and in particular pages 172 to 241.

Within this document on page 19 you will see the LTP average rates increases over the 10 years of the LTP. For the year 2023/24 the LTP forecast increase to rates was approximately 14%.

Since the LTP was approved back in June 2021 there has been significant inflationary pressures and increased debt servicing costs driving the forecasted rate number higher.

Two other material items that were not in the 2021-31 LTP but in the proposed 2023/24 Annual Plan which have contributed to the proposed 17.8% rates increase are an additional \$50 million of capital expenditure due revised budgets and additional operational cost from a bus drivers hourly rate uplift from \$27 to \$30.

We are refusing this part of your request under section 17(d) of the Local Government Official Information and Meetings Act 1987 (the Act) on the basis that the information requested will soon be publicly available. Our current budget process is in the draft stage and will be adopted by Council on 29 June 2023. We will email the links for the full financial information to you as soon as it is published. This is expected in July.

The proposed 17.8% rates increase that was published in the engagement documentation was an average across the region including the Wairarapa, Kāpiti and Hutt costs. For a Wellington residential ratepayer, the average impact of the proposed 17.8% will be approximately \$2.43 per week.
