

Suitably Qualified and Experienced Practitioner (SQEP) Guidance List:

Soil Contamination Assessments

All contaminated land reporting is to be done by a suitably qualified and experienced practitioner (SQEP), under the National Environmental Standard for Assessing and Managing Contaminants in Soil to Protect Human Health Regulations 2011 (NES). For instance, when subdividing or changing the use of land, a preliminary site investigation must exist, to determine the risk to human health.

The following reports are required to be SQEP certified under the NES

- Preliminary Site Investigations
- Detailed Site Investigations
- Remedial Action Plans
- Site Validation Reporting
- Ongoing Monitoring and site Management Plan
- Petrol Tank (UST, ASTs) removal and replacement reports

A SQEP would need to be willing to certify (by signature) that the content of the report complies with good practice and professional standards, and to stand by the conclusions of the report. For example, a person certifying a report should be someone who could ultimately stand in the Environment Court and provide expert testimony, and whose experience and qualifications stand up to Court scrutiny. It's important to note that the practitioner certifying reports is expected to have relevant demonstrated contaminated land experience (up to 10 years).
