

## **Notice of Hearing – Hearing Stream 1 – Proposed Change 1 to the Natural Resources Plan**

**Pursuant to Part 1 and Part 4 of Schedule 1 to the Resource Management Act 1991**

**Proposed Change 1 to the Natural Resources Plan for the Wellington Region (Change 1) –  
Hearing Stream 1 - Overarching Matters and Region-Wide Changes**

**Time: 9:30am**

**Date: 4<sup>th</sup> – 8<sup>th</sup> November 2024**

**Venue: Greater Wellington Regional Council Chamber,**

Greater Wellington Regional Council is now at the stage of commencing hearings on submissions on Change 1, where submitters can speak to the Hearing Panels about their submissions. The hearings are public, and you are welcome to attend any part of the hearing to listen to proceedings, even if you are not speaking to a submission. Hearings will take place in person and with full provision for on-line access.

There are two Hearing Panels appointed for this hearing with overlapping membership:

- The Part 1, Schedule 1 (P1S1) Hearings Panel, appointed by the Council, who will hear and make recommendations on submissions in relation to the Part 1, Schedule 1 provisions of Change 1.
- The Freshwater Hearings Panel (FHP), appointed by the Chief Freshwater Commissioner, who will hear submissions on the Freshwater Planning Instrument component of Change 1.

The hearings will be split up into 5 streams, each covering specific topics. This notice relates only to Hearing Stream 1 - Overarching Matters and Region-Wide Changes.

This is formal notice that **Hearing Stream One (HS1) will commence on Monday 4<sup>th</sup> November at 9:30am** and will cover Overarching Matters and Region-Wide topics of Change 1 and submission points that address Change 1 as a whole and provisions that are best addressed upfront, including procedural matters.

### **Important information for Submitters:**

- The Hearing Panels have released the [First Minute and Directions of Hearings Panels](#). This minute references procedural detail for the hearings.
- Greater Wellington's evidence will be available on the Greater Wellington website by Thursday 10<sup>th</sup> of October 2024.

- Submitters who wish to be heard at the hearing or wish to present a joint case at the hearing must inform the Hearings Advisor (contact details below) by 17<sup>th</sup> October 2024 that they wish to do so.
  - Virtual options will be made available.
- Submitter evidence and legal submissions must be sent to the Hearings Advisor by 17<sup>th</sup> October 2024 (10 working days before the hearing begins).
- The Hearing Panels have encouraged submitters to file any electronic presentations or submission summaries supporting a submitter speaking at the hearing to the Hearings Advisor by 30<sup>th</sup> of October 2024.
- The Hearings Panels have advised that submitter presentations should be approximately 10 minutes, with time for questions from the Hearing Panels following this.
  - If you require a longer presentation time, you need to request this by contacting our Hearings Advisor by 25<sup>th</sup> October 2024. This request should identify why extra time is required, and an indication of how much extra time you may require.
  - The Hearing Panels will have read all submissions, evidence, and pre-circulated documents prior to the hearing. Your presentation should focus on the key points of your submission.
- If you require a translator (NZ Sign or Te Reo Māori) please notify the Hearings Advisor by 10<sup>th</sup> October 2024 (15 working days prior to the hearing).
